### **UJ-CUA** joint undertakings

- The three primary joint UJ-CUA undertakings are
- two programs taking place in Kraków:
   American Law Program (October-April)
   International Business and Trade Summer Law Program (June-July)
- LL.M. in American Law requiring completion of the two Kraków programs and the CUA summer session in Washington D.C. (mid-May-mid-July)
- ► The three programs have many common undertakings, often within the framework of the alumni society of graduates from one or more of the programs and academic exchanges (joint conferences, publications)
- ► The cooperation also supported the 1997 establishment of the legal clinic (poradnia prawna) with the joint leadership of UJ professors Fryderyk Zoll and Maria Szewczyk and UJ doctor Halina Nieć as well as CUA professors Catherine Klein and Leah Wortham. It was the first successful legal clinic in the Central Europe and has been a model to clinics in the civil law worldwide.





### **American Law Program**

- More than 1050 alumni in 22 years
- ► Entry depends on the language proficiency demonstration and conclusion of the contract (including obligation to obey the Honor Code)
- ▶ 12 classes offered every year
- ► Each class is usually one week long (5 x 2,5 hours)
- Dedicated for European students/graduates
- Taught in Kraków by the CUA or collaborating American professors
- Students receive materials before and prepare for in-class discussion and groupwork
- Obligatory attendance
- Access to Westlaw
- Exams online via TWEN (essay-based or case-based)
- Graduation when 8 classes are passed (attendance & exam)
- Scholarships funded by CUA & Kubas Kos Gałkowski law firm (KKG) for minimum 10% of best graduates (50% discount in the LL.M. Program)
- Kubas Kos Gałkowski law firm (KKG) prize for the top graduate



## International Business and Trade Summer Law Program in Kraków

- More than 1000 graduates in 30 years
- One-month program with 4 classes (graduation with 2 classes passed)
- ▶ Recruitment based on interview & motivation letter
- ► Each class is usually two-three weeks long, and the entire program lasts for most often four-five weeks
- Written or take-home exams
- American and European students/graduates study together
- Taught by CUA and European professors
- Externships in law firms in Kraków and Warsaw available for US students
- Field trips (e.g., Auschwitz, Zakopane, Wieliczka)
- Fully accredited by the American Bar Association

- LL.M. (Magister Legum / Master of Laws) is an advanced postgraduate academic degree
- ▶ 85 graduates in 19 years
- In order to obtain an LL.M. degree one must graduate from 1) American Law Program in Kraków, 2) International Business and Trade Summer Law Program in Kraków, 3) two-month program at The CUA campus in Washington D.C.
- Dedicated for everyone who obtained the first degree in law from a university outside the US or Canada and demonstrated English proficiency
- ► The top 10% of American Law Program graduates are eligible for a 50% scholarship toward the LL.M.
